PASTORAL CHURCH BUILDINGS SCHEME

25th This Scheme is made by the Church Commissioners ("the Commissioners") this day of May 2000 in pursuance of the Pastoral Measure 1983, the Right Reverend Timothy, Bishop of Leicester, having consented thereto.

PART I

Declaration of closure for regular public worship

1. (1) The church of Saint Gabriel, and the church of Saint Peter, Beigrave, being two of the three parish churches of the parish of The Resurrection, Leicester, in the diocese of Leicester, shall be declared closed for regular public worship by this Scheme.

(2) The marriage register books appertaining to the said churches shall be dealt with in accordance with section 62 of the Marriage Act 1949 and, subject to any provisions of the Parochial Registers and Records Measure 1978 that apply thereto and any directions thereunder, any other register books and records of those churches which remain in parochial custody shall be dealt with as the Bishop shall direct

PART II

Coming into operation of this Scheme

2. (1) Part I of this Scheme shall come into operation upon such date as the Commissioners, after consultation with the Bishop, shall determine.

(2) Part II of this Scheme shall come into operation upon the day on which it is made by the Commissioners.

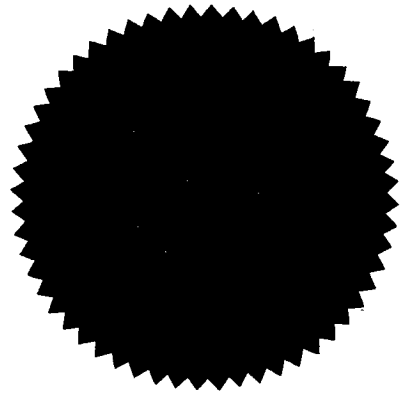
